Civil Rights Complaints

David K. Greer, Sr. Investigator

The Labor and Industry Committee and the Criminal Justice Committee worked together to investigate 15 complaints of discrimination, up 32% vs previous year.

The top 5 types of complaints were as follows:

- Employment 40.00%
- Children Services 13.33%
- Education 6.66%
- Police Misconduct 6.66%
- Use of Force 6.66%

Filing a Union Grievance

The process for resolving a workplace grievance between an employer and a union representing its employees usually follows a standard sequence of steps. Typically, a grievance claim over a <u>labor and employment</u> dispute moves up the chain of command of both the union and the employer.

This process doesn't waive either side's rights to <u>labor arbitration</u>. Rather, the theory is that the lower the level at which a disagreement can be resolved, the lesser the degree of disruption to the workplace.

- Step 1: Document the Issue Step 2: Discuss with a Union Representative Step 3: File the Grievance Formally Step 4: Attend Grievance Meetings Step 5: Escalation and Arbitration
- Step 6: Legal Counsel:

 Seek advice: If the grievance process is complex or you have concerns about your rights, you may wish to consult with an experienced union and employee rights attorney.


